

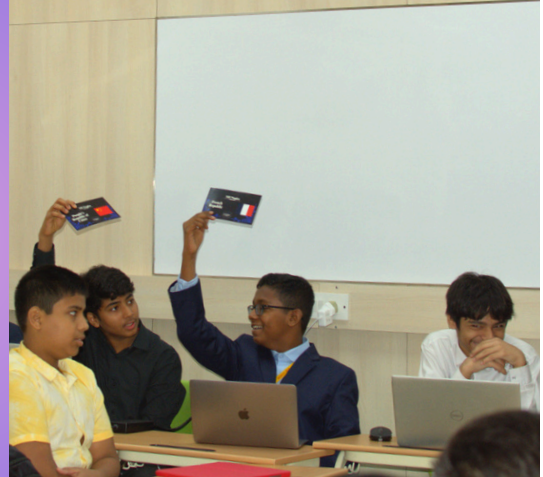

From August 25 to September 27, 1939, a series of crises unfolded in the LON committee. Initially, a directive from the Polish Bloc passed, creating a 2v2 alliance with the USSR and German Reich against France and Poland. However, Franklin D. Roosevelt falsely claimed snipers threatened the Italian Military Head, a ruse revealed to manipulate Italy.



This led to a 1v3 debate where the USA dominated Poland, Germany, and the USSR. On September 1, 1939, Himmler was assassinated in a failed attempt on Hitler. The USSR was later found responsible, causing a split with Germany. Despite intense debates, including a 1v1 between the USSR and Germany, the committee worked towards peace.

They passed a directive for returning Danzig to Germany, fundraising for bomb damage repairs, and achieving full majority approval. The committee ended with a light-hearted Motion of Entertainment, concluding with meaningful memories and insights into history.

At the UNSC's session on the Arctic Circle crisis, intense power dynamics emerged. The United States, United Kingdom, and Sierra Leone dominated the debate. Chaos ensued when Russia allied with a clandestine group, pulling China into a coalition to control the Arctic Circle.



Betrayed by Russia, China faced swift sanctions from the USA, sparking diplomatic uproar. The USA led a resolution condemning Russia, China, and the coalition, escalating tensions with warning shots exchanged. Interpol uncovered evidence linking Russian, Chinese, and coalition accounts to illicit transactions, fueling the volatile proceedings.

The USA's resolution ultimately prevailed, signaling a new world order endorsed by the UN. These events highlight the fragile balance of power and the urgent need for multilateral cooperation to safeguard global interests.
